### Waiver of Liability for Junior Members

The undersigned Junior and Parent or Legal Guardian, by signature below, agrees that the St. Louis Rebels West Coast Swing Dance Club, and any other event host involving the St. Louis Rebels West Coast Swing Dance, Club shall be held harmless for any liability, injury, or damage to self or belongings (including clothing), incurred by said Junior, and the Junior/Parent/Guardian agrees to hold harmless and indemnify the St. Louis Rebels West Coast Swing Dance Club for damage or injury caused to others by said Junior either during, before, or after any dance demonstration or during open social dancing. This waiver will be in effect as long as the Junior qualifies as a Junior Member of the St. Louis Rebels West Coast Swing Dance Club or until or unless the Junior and Parent/Guardian rescinds it in writing to the St. Louis Rebels West Coast Swing Dance Club regardless of membership status.

Medical Emergencies: Unless a medical release is filled out and duly signed transferring temporary authorization for another assigned responsible guardian, the parent/guardian is the responsible party. No Junior will be allowed to leave for an out-of-town event unless the parent/guardian has signed a medical release to the assigned responsible guardian, or is physically in attendance at the same event.

Chaperone Responsibilities: The Rebels, any other club, event hosts, or group hosts are not liable for a Junior's conduct prior to, during, or after a dance event/party. A Junior member must be accompanied by either a Parent or Guardian, or a responsible adult chosen by the parent. No individual, group, club, or association can be held legally accountable for any consequences of such activity either on or off the premises of the dance activity, other than the Junior and his/her parents. The Parent/Guardian also agrees that if necessary, he/she will either immediately travel to pick up the child, or will pay and arrange for the child to leave the event under whatever circumstances may require them to be excused from the event.
